The Mising Autonomous Council processes to provide financial incentives to meritorious & talented students belonging to economically weaker sections of society for undergoing higher education under the scheme "Agom Migang Tabu Taid Shiksha Sarathi Scheme for grant of financial incentives to Meritorious Student for Higher Studies for the financial year 2023- 24" with the following criteria.

- 1. Courses for which Incentives will be covered:
 - a. M.Phil. / Ph.D. in any Govt. Institution.
 - b. M (Tech) / M.A. / M. Sc. in any Govt. Institution.
 - c. B.E., B. Tech, etc. in any Govt. Institution.
 - d. MBA in any Govt. Institution.
 - e. MBBS / BDS / BHMS/ BVSc/ in any Govt. Institution.
 - f. Any other Professional. Degree, Professional. Diploma or Post-graduation courses in any Govt. Institution or govt. recognized institutions, subject to approval by the Executive Council of MAC.

2. Eligibility:

- a. The applicant must be a resident of MAC area or MAC notified Villages.
- b. Students belonging to Mising community but not residing in MAC area may also apply.
- c. The applicant must be a student of a current course
- d. The students must not have received any Incentives or sponsorship from any other sources for the said course.
- e. Gross annual income of parents should not be more than Rs. 4.00 lakh per annum.

3. Amount of Incentives:

- a. This is a one-time Incentive provided by MAC depending on the availability of funds and total number of eligible applicants.
- b. Poorer among the applicants will be given priority.
- **4. Procedure for award of Incentives:** The award of Incentives will be regulated as follows:
 - a. Application: The candidate must fill the online appliaction forms by visiting the
 official website <u>www.macassam.org</u> or can availed at other social media handles of
 MAC.
- **5. Selection:** Selection shall be made strictly on a Merit & Income basis which will be scrutinized, shortlisted, and recommended by a Selection Committee.

6. Other Terms and Conditions:

- a. MAC reserves the right to alter, modify, interpret or withdraw the Incentives scheme as considered necessary without any notice.
- b. The Incentives is for students of any community of MAC areas and Mising students residing anywhere in India.
- c. The Incentives will not assure or guarantee any employment.
- d. The court of jurisdiction for any dispute will be at Dhemaji, Assam.
- e. Applications not in the prescribed format or received after the last date of submission of the Application Form or not forwarded through the Head of the Institution with complete supporting documents are liable to be rejected.

Application can be applied through online mode only:

- a. Candidate must Complete online application form by uploading with all the supporting documents as mentioned in the application form and attached herewith this notification as Annexure -A,B,C and D duly certified and verified by their Head / Principal / Head of the Institute / Dean of the Institute / College / University and recommended by the General / Executive Member of MAC. .
