# Invitation of Expression of Interest (EOI) for Mobile Van Publicity with LED Screens in Mising Autonomous Council Constituencies

In pursuance of the approval of the 78th Executive Council Meeting held on 08-08-2024 at the Conference Hall of the Mising Autonomous Council (MAC), the MAC, Gogamukh, Dhemaji, is pleased to invite Expressions of Interest (EOI) from reputed and experienced agencies/organizations for the provision of mobile van publicity services. The selected agency will be required to provide six (6) mobile vans equipped with LED screens to display advertisements related to the Council across the 36 constituencies of the Mising Autonomous Council.

The period of agreement will be for 3 Months.

### Scope of Work:

## 1. Deployment of Mobile Vans:

- Required Six (6) mobile vans equipped with LED screens.
- Each van will travel across all 36 constituencies of the Mising Autonomous Council.
- The vans will display advertisements related to the Council's initiatives, programs, and public awareness campaigns.

# 2. LED Screen Specifications:

### 3. Vehicle Requirements:

- The mobile vans must be in good condition and suitable for the purpose of mobile publicity.
- CAR Rental, fuel, driver, and other logistics must be included in the service package.

# 4. Management and Operations:

- The agency must manage the entire operation, including content display, vehicle management, and coordination with the Council.
- Daily monitoring and reporting of the van's movement and display content will be required.

# 5. Rates: Rates for Vehicle, Control Systems and LED Screen must be submitted in rental basis for 3 Months.
