Notice Inviting Expression of Interest (EoI)

Interested parties fulfilling the eligibility criteria given below may submit their Expression of Interest on or before 20-09-2024 by 3 P.M. The duly filled-in EOI may be submitted in a sealed envelope super-scribing "Expression of Interest for broadcasting advertisement, publicity related work such as arrangement, and coordination of News Reporter and Press Conference etc.and other publication related works of the Mising Autonomous Council" to the Office of the Principal Secretary, Mising Autonomous Council, Gogamukh, Dhemaji.

A. Eligibility Criteria

- It is mandatory to have Google Monetization in addition to the website registered in the name of the applicant news organization being one year old.
- 2. The applicant news agency must have 20,000 Subscribers in a one-year-old YouTube channel.
- 3. The applicant news agency must have 10,000 followers on a one-year-old Facebook page.
- 4. It is mandatory for the applicant news organization to have a one-year-old qualification for broadcasting various news stories as well as the programs of community development for its Viewers.
- 5. It is mandatory for the applicant news agency to have YouTube channel, Facebook page and Website.

B. Rates: Submit Required rates for the scope of Works as given in the data :-

- The applicant news agency is required to submit the number of Subscribers and Followers in writing.

- It is mandatory to submit 5 photos of the digital advertisement aired on a website registered in the name
 of the applicant news agency.
- 5. List of staff strength with biodata.
